Counselling Consultation with SURVIVOR SUPPORT SPECIALIST: **CASE OFFICER to further discuss external process**

SURVIVOR CONFIRMS decision through email communication

SURVIVOR SUPPORT SPECIALIST: CASE OFFICER provides ongoing CASE MANAGEMENT and engagement with internal & external stakeholders

For purposes of forensic analysis of evidence case reported to SAPS and referred to FCS official. No prescription period for lodging a criminal case, survivor can decide when and if the case goes to court. CAS number provided regardless of survivor's decision.
