STATEMENT OF INTENT

I am an independent criminal justice consultant working with research organisations, assisting legal teams, and consulting with local and international media organisations. I thus have a wealth of experience navigating complex and sensitive cases with discretion, integrity, and judicious critical analysis. This would be an asset to Council, as would my experience as a former UCT academic. During my 18 years lecturing on the LLB and LLM programmes I acquired an intimate knowledge of UCT, the challenges it faces and the kind of ethical leadership that is required to navigate them.

The tertiary sector generally, and UCT specifically, has experienced extraordinary volatility for several years. Funding challenges, leadership crises and recurring protests have all placed the institution under enormous strain.
