Robin Cupido holds BA, LLB and LLM degrees from Stellenbosch University. She joined the UCT Faculty of Law as a lecturer in 2019 and started her PhD studies in 2020.

Robin Cupido's thesis investigates whether Online Dispute Resolution (ODR) can find successful application in various African countries.

She begins by considering the global development of ODR, highlighting its link to the creation and growth of the internet. She then focuses on the various challenges that African countries could face in implementing ODR, as well as the unique attributes that various countries on the continent have that would facilitate the successful adoption of ODR. To determine the feasibility of such adoption, she conducts a comparative study between identified technological leaders in Africa, namely South Africa, Nigeria and Kenya. Using an assessment of the legal frameworks and technological readiness of each of these nations, Cupido makes some suggestions as to how ODR can find successful application in the selected African countries, and in others. Through her research, Cupido aims to lay a solid basis for future ODR scholarship in Africa.

Eichstedt, Anneke

Thesis Title: *“What the f*ck just happened?”: a study of the post-rape decision-making on safety, response and justice by adolescent girls in South Africa*

Anneke Eichstedt holds a BA in Sociology from the University of Bremen, Germany. In 2015, she joined UCT's Centre of Criminology and completed her MPhil qualification in Criminology, Law, and Society. She has worked on her PhD whilst at the Centre.

Anneke Eichstedt's thesis focuses on the decisions that South African adolescent rape survivors make following their victimisation. Based on in-depth interviews with 40 adolescent sexual violence survivors and their caregivers, peer educators, and counsellors, she investigates how the young women navigate the 'why' and 'how' of what has occurred and the options for seeking help, safety and justice. Using a novel application of Pierre Bourdieu's sociological theory of practice, she finds that teenagers' decisions are not made in a vacuum but are underpinned by the *habitus* of

learning gleaned from growing up in South Africa's violent communities. She shows how the teenagers' decisions are both shaped by their social environments and how they shape their own outcomes in contexts of having to cope with significant deficiencies in practical and emotional support resources, to navigate dangerous situations and the experience of sexual victimisation, and to seek the kind of protection that makes sense for them and their circumstances.

Engoru, Ivan

Thesis Title: A critical analysis of the Ugandan Companies Act, 2012, in the search for an appropriate legal framework for small and closely-held companies in Uganda in the light of the experiences of South Africa and the United Kingdom

Ivan Engoru has an LLB(Hons) from Makerere University and an LLM from the University of Warwick. He is an advocate of the High Court of Uganda and an Assistant Lecturer, School of Law, Makerere University. He also holds a certificate in mediation from UCT.

Ivan Engoru's thesis analyses whether the Ugandan Companies Act 2012 (the Act) provides an appropriate and effective legal framework for the regulation of small, closely held companies (SCHCs) in Uganda, particularly when considered in relation to Uganda's Commercial Justice Reform Program's stated objectives to deliver simple, accessible, and flexible companies' legislation. Drawing on experiences in South Africa and the United Kingdom, Ivan Engoru evaluates the Act with reference to criteria such as audit and financial reporting requirements; limitations on the number of members; and the restriction of membership to natural persons. Based on his analysis, he concludes that the types of legal forms and their categorisation, and the corporate governance and instructional framework provided for by the Act do not effectively meet the needs of SCHCs in Uganda. He also proposes various measures for reform including revision of the Act along the lines of South African and United Kingdom companies' legislation.

Maraire, Wesley

Thesis Title: Enhancing access to justice in Zimbabwe: an empirical exploration of integrating socially appropriate dispute resolution to overcome barriers within the formal justice system

Wesley Maraire holds BSocSc, BSocSc(Hons), and MPhil degrees from UCT.

Zimbabwe's justice system appears to favour the wealthy and powerful, leaving many individuals, especially in rural areas, to rely on informal means to resolve disputes. Wesley Maraire's thesis uncovers the factors contributing to this disparity. His research included in-depth interviews with a diverse range of legal professionals. He found that the European-based adversarial legal system, implemented during colonisation, is incompatible with traditional dispute resolution methods. Moreover, as he shows, the adversarial system is expensive, complex, and geographically distant for most Zimbabweans, and leads to their being dependent on informal methods that lack the official enforceability of the formal system. Based on his findings and on consideration of countries such as South Africa and Australia where attempts have been made to adapt the legal systems to serve citizens better, Wesley Maraire suggests incorporating aspects of traditional dispute resolution into the official system in Zimbabwe, thereby to make it culturally relevant and accessible to diverse communities. His empirical research, grounded in qualitative data analysis, ultimately calls for a reformed justice system in Zimbabwe that is more inclusive and culturally sensitive than at present, and ensures equality of access to justice.

Mzezewa, Sinikiwe
Thesis Title: uBuntu and certainty in commercial contracting: a study of burial societies in Cape Town

Sinikiwe Mzezewa holds an LLB from the University of Venda and an LLM in International Trade Law from UCT. She has worked at UCT as a teaching assistant in the Department of Commercial Law and subsequently as a lecturer whilst pursuing her PhD.

Sinikiwe Mzezewa's thesis delves into the contracting practices of burial societies. Burial societies are mutual rotating savings groups utilised for financing funerals in indigenous communities. Members agree to contribute monetarily and non-monetarily in exchange for support during times of death or bereavement within their families. Flexible practices and ubuntu-based dispute resolution characterise the contracts amongst members. Sinikiwe Mzezewa's investigation centres on determining the certainty and enforceability of these contracts. She draws on both the existing literature and her own empirical data collected in Cape Town. Her findings reveal that burial societies employ various methods to ensure the reliability of their contracts. The social bonds among the parties, their circumstances, and the long-term nature of the contracts necessitate flexibility in the agreements. As a result, she concludes, the contracts are indeed certain and enforceable. Sinikiwe Mzezewa's thesis contributes novel insights to current understanding of customary contracts within the South African context.

Ndamase, Yolani

Thesis Title: Reforming the models of competition law and addressing intersectional discrimination in South Africa

Yolani Ndamase completed her LLB (with distinction) at the University of Fort Hare and LLM in commercial law at UCT. She began part-time study towards her PhD in 2019 while

lecturing at Rhodes University. Yolani Ndamase's thesis explores the effectiveness of the current Competition Act in addressing the issue of excessive market concentration and monopolistic markets that continue to stifle the participation of firms owned by historically disadvantaged individuals, particularly black women-owned businesses. Despite the abolition of past discriminatory competition laws and the enactment of the Competition Act, the intended goal of reducing market concentration and increasing the participation of black South Africans has not been achieved. Ownership trends continue to disproportionately represent the minority white population. She attributes this failure, at least in part, to the normative framework and philosophies relied upon by the Competition Tribunal and courts when handling competition-related matters. Furthermore, she recommends the implementation of distinct measures to support black-women-owned businesses, because their unique identity places them at the intersection of race and gender.

Sammy, William Kiema
Thesis Title: *'Open Skies For Africa, 'a principled approach to the implementation of the Single African Air Transport Market (SAATM)*

William Sammy completed his LLB degree at the University of Nairobi, Kenya, in 2018 and his LLM at UCT in 2020. He began his doctoral study in UCT's Faculty of Law in 2021. Previously, he practised as an advocate of the High Court of Kenya.

Aiming to propose a principled approach to the implementation of the Single African Air Transport Market (SAATM) initiative, William Sammy's thesis studies the collaboration of African countries in the air transport industry. He argues that a principled approach involves the holistic implementation of the Yamoussoukro Decision (YD) as undergirded by the principle of variable

geometry. It also involves all relevant stakeholders within the broader context of the African Union's Agenda 2063 initiatives. Such an approach puts a premium on supporting aviation policies such as safety, security, sustainable aviation financing, fair competition, and environmental concerns. Wiliam Sammy's study finds that whereas other regions, such as the EU and the ASEAN, have successfully established similar initiatives through evolutionary processes shaped by each of these regions' unique circumstances, the realisation of SAATM has lagged due to the lack of an approach that appreciates Africa's unique circumstances.

Sindane, Ntando
Thesis Title: *Abezimu/Badimo (ancestors) and copyright law: from the Decolonial Turn to the pluriversal author*

Ntando Sindane completed his LLB and LLM degrees at the University of South Africa in 2017 and 2020 respectively and began his PhD studies in 2021. He is currently a lecturer in the Department of Public Law and Jurisprudence at the University of the Western Cape.

Ntando Sindane's thesis focuses on authorship in copyright law from the perspective of knowledge patterns of people from the global South, and the perspective of black people in particular. He engages in a deeply philosophical and decolonial inquiry to investigate how authorship is understood by black people and argues that such an understanding of authorship should be reflected in prevailing copyright law systems. He observes that the current global copyright regime is inherently Eurocentric, colonial and biased towards Euro-American capitalist sensitivities. Through his judicious consideration of authorship through the lens of decolonial theory, Ntando Sindane makes a novel contribution to the discipline of intellectual property and demonstrates clearly that authorship is inherently pluriversal. Most importantly, his thesis reveals that pluriversality engenders scholarly acceptance that *Abezimu/*

Badimo (ancestors) are an author in decolonised copyright law.

Von Broembsen, Marlese
Thesis Title: *New frontiers for labour law: collective bargaining for workers in global supply chains and informal self-employed workers*

Marlese von Broembsen obtained BA(Stell), LLB (UCT), MA (UWC) and LLM (Harvard), before commencing with PhD studies at UCT in 2017. She continues to work in the non-profit sector, focusing on women workers.

Marlese von Broembsen's thesis explores the relevance of labour law's two core institutions, the contract of and employment and collective bargaining. Focusing on two categories of workers in the global South, garment workers in global supply chains and street vendors, her thesis explores the shifts required of the institution of collective bargaining to realise collective bargaining rights for these workers. In particular, she considers and argues for transnational supply-chain bargaining for garment workers and, given local governments' control of street vendors' workplaces, collective bargaining for street vendors in relation to local governments. Questioning the continued relevance of the contractual paradigm as the basis for labour rights, Marlese von Broembsen argues for a new understanding of the role of collective relations in labour law.

OFFICERS OF THE UNIVERSITY

CHANCELLOR

The Chancellor wears a gown made from dark blue silk. The front of the gown has facings down each side made of dark blue velvet embroidered with a gold floral design. The gown and sleeves are lined with pale blue silk and the sleeves are looped up in front with a gold cord and button. The yoke of the gown is edged with gold cord. The gown is worn with a square blue velvet hat with a soft crown and gold tassel.

VICE-CHANCELLOR

The Vice-Chancellor wears a gown made from bright blue silk. The front of the gown has facings down each side and sleeve-linings of pale blue silk. The sleeves are looped up in front with a gold cord and button and the yoke of the gown is edged with gold cord. The gown is worn with a black velvet bonnet with a silver cord.

DEPUTY VICE-CHANCELLOR

A Deputy Vice-Chancellor wears a gown made from dark blue silk. The gown has closed sleeves with an inverted T-shaped opening at the level of the elbow to free the arms. The front of the gown has facings of light blue down each side. The sleeves are lined with light blue and the yoke of the gown is edged with silver cord. The gown is worn with a black velvet bonnet with a silver cord.

CHAIR OF COUNCIL

The Chair of Council wears a gown, of the same pattern as that worn by the Vice-Chancellor, made from light blue silk. The front of the gown has facings down each side and a yoke of dark blue. The sleeves are lined with dark blue and the facings and yoke are trimmed with gold cord. The sleeves are looped up in front with a gold cord and button. The gown is worn with a black velvet bonnet with a gold tassel.

MEMBERS OF COUNCIL

Members of Council wear graduate-pattern gowns made from black silk. The front of the gown has 10cm wide, light blue facings down each side trimmed with dark blue cord. The gown is worn with a black velvet bonnet with a blue cord.

REGISTRAR

The Registrar wears a gown made from black silk. The front of the gown has 10cm wide facings of blue silk down each side. The gown is worn with a black velvet bonnet with a white cord.

PRESIDENT OF CONVOCATION

The President of Convocation wears a gown made from black silk and has long closed sleeves with an inverted T-shaped opening at the level of the elbow to free the arms. The front of the gown has facings down each side and sleeves of blue silk. The gown is worn with a black velvet bonnet with a blue tassel.

UNIVERSITY ORATOR

The University Orator wears a gown of gold silk with bright blue silk facings and a yoke edged with gold cord. A black mortar board with a gold tassel is worn with the gown.

ACADEMIC DRESS (continued)

GOWNS

A plain black gown styled after the pattern of the Oxford scholar's gown is worn by diplomats, and Bachelor's, Honours and Master's graduands. Senior doctoral graduands wear a scarlet gown, with facings the colour distinctive of the faculty in which the degree is awarded. PhD graduands wear a scarlet gown without facings.

HOODS

The hood is particular to the qualification and the faculty. Diplomates and Bachelor's graduands wear a black hood lined with white and edged with the colour distinctive of the faculty. Master's graduands wear a black hood lined with the colour distinctive of the faculty and edged with white, except in the case of the hood for the MMed degree, which is edged with red. Senior doctoral graduands wear a hood of the colour distinctive of the faculty and a black velvet bonnet with a cord of the colour distinctive of the faculty in which the degrees is awarded. PhD graduands wear a hood of scarlet lined with black and a black velvet bonnet with a cord of the colour distinctive of the faculty in which the degree is awarded.
