# **About the Funding Opportunity**

#### **Purpose:**

This funding opportunity, offered by the British Academy, supports research collaborations that advance evidence-informed policymaking in Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, **South Africa**, Turkey, Thailand, Vietnam, and/or Least Developed Countries. The initiative aims to foster international partnerships, build the evidence base for policymaking, and promote sustainable, impactful research practices.

## **Objectives:**

- Develop collaborations between researchers, policymakers, and practitioners in the UK and eligible countries.
- Enhance the use of research evidence throughout the policymaking cycle—from ideation and framing to implementation and evaluation.
- Address structural, political, and social barriers to effective evidence use in policymaking.
- Explore the political economy of evidence and its impact on policy inclusivity and outcomes.
- Support the development of sustainable practices that embed evidence-based decision-making in policymaking.

#### **Focus Areas:**

- Understanding the conditions necessary for fostering effective evidence use in policymaking.
- Examining how contextual and political factors shape policy content and inclusivity.
- Assessing the positive and negative effects of evidence use on policy outcomes.

# **Funding Details:**

- Awards of up to £150,000 for 12-month projects.
- At least 20 awards are expected to be granted.
- Projects must be Official Development Assistance (ODA)-eligible.

#### **Eligibility Criteria**

This programme will support grants in the following areas to develop the evidence base further. Applications may consider interventions across one or more mechanisms of change, including:

- Awareness and attitudes.
- Mutual understanding and agreement.

- Communication of and access to evidence.
- Interaction between policymakers and researchers.
- Skills development.
- Structures and processes related to evidence-informed policymaking.

#### Eligible research activities include:

- Research on how evidence use theory, and research has been implemented in practice.
- Research or activities related to knowledge systems strengthening and/or organisational change to support evidence use in practice.

## Fields of Work:

The Academy is seeking to support awards in the following fields:

- Environment, Sustainability & Nature.
- Transformative Technologies.
- Health & Wellbeing.
- Cities & Urbanisation.
- Global Order, Geopolitics, and International Affairs.

## **Principal Investigator (PI) Requirements**

- Each project must be led by a named Lead.
- The PI must be a researcher in a discipline within the social sciences or the humanities.
- The PI is responsible for directing the research, managing the project, and meeting the reporting requirements.
- The PI must hold an established role at an eligible university or research institute in the UK, Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, **South Africa**, Turkey, Thailand, Vietnam, and/or Least Developed Countries.
- The PI's position must last at least the duration of the grant funded by the Academy.
- Independent researchers are not eligible for this round.

# **Co-applicant Requirements:**

- If the PI is based in the UK:
  - The team must include at least one researcher based in Brazil, Egypt, Indonesia, Jordan, Kenya, Malaysia, Philippines, South Africa, Turkey, Thailand, Vietnam, and/or Least Developed Countries.
- If the PI is based in one of the eligible countries:
  - o The team must include at least one researcher based in the UK.

# **Submission process**

This proposal requires the PI to complete an online application on the funder portal <u>Flexi-Grant Grant Management System</u> (GMS) system, as well as requesting institutional approval via UCT's electronic Research Administration (<u>eRA</u>) system, prior to submission to funder.
