About the Funding Opportunity

The <u>Large Research Grants on Education Program</u> supports education research projects that will contribute to the improvement of education, broadly conceived.

Proposals to the Research Grants on Education program must be for academic research projects that aim to study education. Proposals for activities other than research are not eligible (e.g., program evaluations, professional development, curriculum development, scholarships, capital projects). Additionally, proposals for research studies focused on areas other than education, are not eligible.

Spencer foundations anticipate awarding grants with budgets across each of the following funding tiers –

- 1. \$125,000 to 250,000.
- 2. \$250,001 to \$375,000; and
- 3. \$375,001 to \$500,000.

This program is "field-initiated" in that proposal submissions are not in response to a specific request for a particular research topic, discipline, design, method, or location. Our goal for this program is to support rigorous, intellectually ambitious and technically sound research that is relevant to the most pressing questions and compelling opportunities in education.

Eligibility Criteria

- Projects proposed may not be longer than 5 years in duration.
- Applicants can request funding amount- max USD 500,000 and min USD 125,000
- Principal Investigators (PIs) and Co-PIs must have an earned doctorate in an academic discipline or professional
 field, or appropriate experience in an education research-related profession. While graduate students may be
 part of the research team, they may not be named the PI or Co-PI on the proposal.
- Projects that are primarily comprised of activities other than education research (e.g., request for funding book writing, curriculum or technology development, technology purchases, philanthropic support for nonprofits or other service providers, program evaluations), or scholarships are not eligible.

Application Process

Stage 1: Intent to Apply form (Deadline 14 Jan 2025)

- This does not require the applicant to complete UCT's eRA application.
- The applicant to complete an Intent to Apply form on funder's portal here. Once completed and submitted, you will have access to the Full Proposal application in funder's online portal.

Stage 2: Full Proposal application (Deadline 11 February 2025)

 This proposal requires the PI to complete an online application on the funder portal https://spencer.smartsimple.us,
 as well as requesting institutional approval via UCT's electronic Research Administration (eRA) system, prior to submission to funder.
