

DSI-NRF Postgraduate Student Funding for the 2026 Academic Year – CALL NOW OPEN

The DSTI and NRF are pleased to announce a call for new applications for **EXTENSION MASTERS AND DOCTORAL Student Funding for the academic year 2026**. All continuing students who are eligible for a second or third year of funding must submit a Progress Report and not a new application.

The NRF **minimum academic requirement** for postgraduate funding is **65%** for the previous degree. Successful applicants will be funded either at **Full Cost of Study (FCS)** or **Partial Cost of Study (PCS)**. The FCS funding will be awarded to South African citizens and Permanent Residents only, who are either **financially needy** (i.e., those whose combined household family income is less than or equal to R350 000 per annum), **living with a disability** or **exceptional academic achievers**. However, the PCS funding will be awarded to **5% of international students** including South African citizens and Permanent Residents who could not be funded under FCS but meet other minimum requirements for the NRF scholarship funding criteria. The scholarships are intended to support master's and doctoral candidates to pursue studies in all areas of **Science, Engineering, Technology, Social Sciences, and Humanities**.

- Students may only submit ONE application
- Please Select the correct options under application category *IF* you are applying under your supervisor's grant. This does not apply to applicants. Please read [pages 14 – 16](#) of the above application and funding guide. It is very important that you apply correctly so that your application be screened and reviewed with the correct panel. Your careful attention to this is thus crucial
- When completing the application support input section, please ensure that the correct email address for your referees is captured. WHAT TO EXPECT AFTER YOU SUBMIT YOUR APPLICATION?

- Once you submit your application, it will automatically be routed to UCT
- For your application to be considered for 2026 funding, you must submit your application and all supporting documentation on or before UCT's CLOSING DATE
- After DA screening, eligible applications will be submitted to UCT's internal review panel
- Following UCT's internal review panel process, the DA will consolidate all results for submission to NRF for their further consideration.
- Ineligible applications will be rejected. Your application status can be monitored via your NRF Connect Profile
- The NRF will inform all applicants of the outcome of their application

INCOMPLETE APPLICATIONS

Please be advised that no incomplete applications will be submitted to NRF. It is the applicant's responsibility to familiarise themselves with all eligibility criteria and requirements. During DA screening, if your application is incomplete, the office will contact you via email requesting information. Such requests must be responded to within 24 hours. Failure to do so will result in your application being disqualified and as a result, will not be considered.
