FINDING FUNDING

7 KEY THINGS TO KNOW ABOUT FUNDING YOUR POSTGRADUATE STUDIES

1 BE FLEXIBLE. Financial assistance for postgraduates comes in various forms. Some are administered by the university and others by external agencies and donors. Be sure to investigate a range of options.

2 KEEP THOSE MARKS UP. Many postgraduate awards are based on either academic merit alone or a combination of financial need and merit. While there are awards based only on financial need, the better your academic scores, the more awards are available.

3 PLAN AHEAD. Start looking for funding opportunities well in advance. Opportunities for funding are often announced months before the deadline to register for your degree (e.g., in the year preceding the start of your postgraduate studies).

4 FOLLOW @UCTPOSTGRADS Our Twitter account announces bursaries, scholarships and other opportunities. Otherwise, details are available on the Postgrad Hub's electronic noticeboard.



5 GATHER AS MUCH INFORMATION AS POSSIBLE. The Postgraduate Funding Office (PGFO) offers a range of material to help you find funding for your studies. Booklets, such as this one, and handbooks can be obtained from the PGFO or downloaded from the Postgrad Hub.

6 PREPARE FOR A BALANCING ACT. With the exception of some prestigious scholarships and a specific group of UCT-supported, full-cost awards, full financial support via a single award is rare. This means financing your postgraduate studies is likely to involve a combination of bursaries, part-time employment and loans. Bear in mind, some awards cannot be held concurrently with others. So, when you plan, consider as many sources of support as possible.

7 ASK FOR HELP. The PGFO is within easy walking distance of most faculties and departments on Upper Campus. Our staff are there to advise you on the diverse funding opportunities available to postgraduates and help with the submission of applications. Also speak to researchers and potential supervisors as they may have access to grantholder bursaries.

IMPORTANT POINTS TO CONSIDER REGARDING FUNDING ELIGIBILITY

Postgraduate funding is not automatically granted based on admission to UCT or as a follow-on to the undergraduate funding you may have had. There are many awards, each with specific criteria and rules that must be fulfilled/matched. Hence there is an application process for all awards, including deadlines for submission dates, which must be adhered to.

The PGFO is the guardian of all these funds. We are responsible for managing these funds and ensuring that the recipients of each scholarship are paid.

Annual funding limitations

Apply to the scholarships and bursaries managed by the PGFO. Students can accept more than one scholarship as long as the total amount doesn't exceed these figures each year.

Please note that financial need* applicants will be awarded a bursary which is a contribution towards cost of attendance which is calculated as follows:

- tuition
- once-off book allowance
- res/rental or live-at-home allowance
- food allowance
- travel allowance

Eligibility criteria

- **TYPES OF DEGREES:**
Honours, master's & doctoral
- **STUDENT STATUS:**
Most funding opportunities are only available for full-time studies, but there are a few options available to students studying part-time
- **NATIONALITY:**
Most of the scholarships are only available to South African citizens or permanent residents. However, there are a few scholarships for students located elsewhere in the world

Ineligible categories

- These degrees do not qualify for funding from the PGFO because they do not have a research focus: diplomas, certificates, BArch & LLB.
- Any fourth year linked to an undergraduate degree
- In addition, a second degree at the same level as one they already hold e.g. a second honour's degree

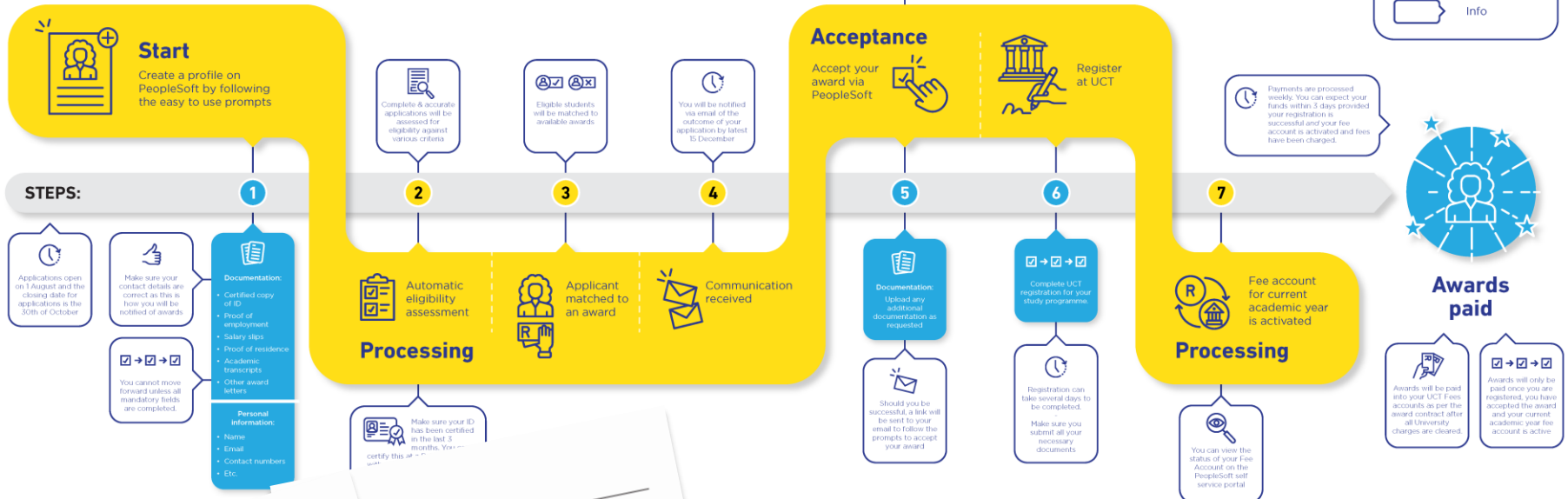
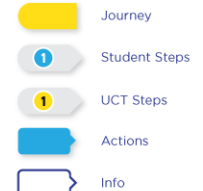


Postgraduate Financial Aid

A step-by-step guide of the process

UCT allocates a variety of postgraduate funding awards for South Africans and permanent residents through the Postgraduate Online Funding Application. These awards are allocated based on merit, financial need, or both. This document will guide you through how to apply.

How do I know what I am eligible for?

UCT manages many awards and funds within the financial aid process. The eligibility for these awards differ depending on the information you upload, the system will determine your eligibility for various awards and match your financial aid accordingly. You do not need to worry about which financial aid awards you are eligible for, the system does this for you.

Why is my document not being accepted?

Make sure you are uploading an accepted file type. These are listed on the portal. There is no size limit but large files may cause system or browser timeout. You can compress your documents to reduce the file size.

Which documents do I need to upload?

The online application page will list the required documents that need to be uploaded. Please note that if documents require certification, the certification needs to be no older than 3 months. You can get documents certified at a police station or by a notary (e.g. lawyer or registered CA(SA).)

How long does the Postgraduate Financial Aid application process take?

The application process opens annually on 1 August. You will be notified via email of the outcome of your application by 15 January. Successful applicants will receive their award within 3 days of successful completion of the PGFO registration and acceptance of the award.

Where will my award be paid?

Your award will be paid into your UCT Fee Account in line with the contract. The amount paid will be after all University charges are cleared.

Where can I get help on how to apply for financial aid?

There are a number of useful tools to assist you in completing your online application. These include an online tutorial and in-person training sessions.

Can I appeal the Financial Aid decision?

Postgraduate students can submit an appeal based on legitimate reasons, as agreed by the Postgraduate Studies Funding Committee, which include:

- Request reassessment of the online funding application for changed financial circumstances
- Extension of funding term
- Request to hold funds that exceed maximum award limit
- Deferral of award, and
- Change to programme of study.

The appeals form is available on the website (see link below). Completed appeals forms should be submitted to the Postgraduate Funding Office on PGApp@uct.ac.za. No appeals based on missed deadlines or late applications will be considered.

Please note: the decision on your appeal is final, please do not appeal the decision.

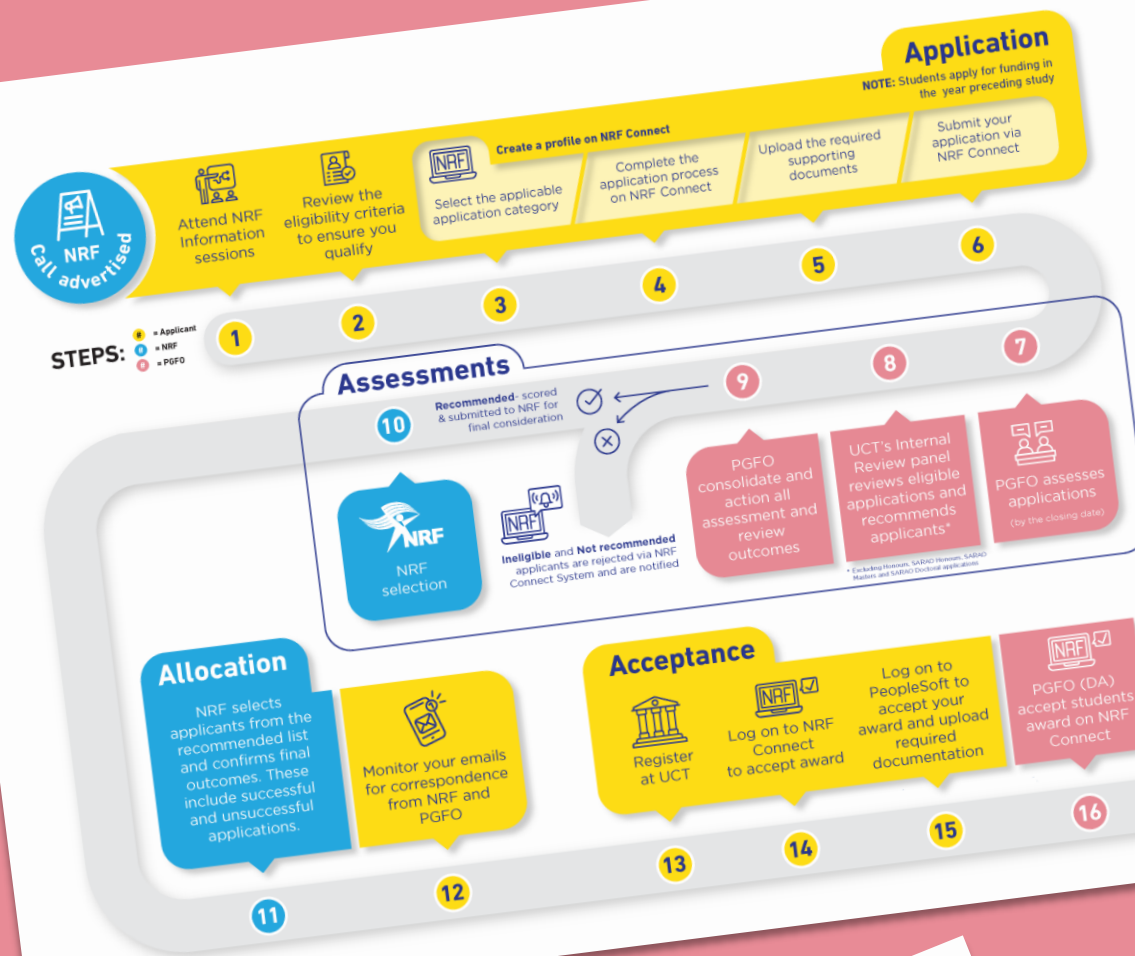

NRF Funding Applications

A step-by-step guide to the process

The National Research Foundation (NRF) provides postgraduate funding aimed at promoting research and innovation in South Africa. This funding scheme is designed to support postgraduate students in their pursuit of an Honours, Masters, Doctoral and Postdoctoral study/research. The NRF provides these grants based on both merit and potential for the research to contribute to the knowledge economy of South Africa. The funding covers a range of costs associated with postgraduate study including tuition fees, living expenses, research costs and travel grants for conference or research visits. This document is intended to serve as a guide to assist (1) New Honours, (2) First time Masters and Doctoral, (3) Extension Masters and Doctoral and (4) SARAO Honours, Masters and Doctoral applicants in applying for funding from the NRF.
