Funding ranges from USD 125 000 to USD 500 000. Projects may run for up to five years.

### **Funder deadlines:**

Pre-proposal deadline: 24 February 2026
 Full proposal (by invitation): 23 June 2026

## **About the Funding Opportunity**

The <u>Large Research Grant programme</u> supports intellectually ambitious studies that advance understanding of educational processes and outcomes. Proposals can draw on different research traditions and methods, including qualitative, quantitative or mixed approaches. Spencer welcomes work that engages with pressing challenges in education across diverse global contexts.

Spencer foundations anticipate awarding grants with budgets across each of the following funding tiers -

- 1. \$125,000 to 250,000.
- 2. \$250,001 to \$375,000; and
- 3. \$375,001 to \$500,000.

This program is "field-initiated" in that proposal submissions are not in response to a specific request for a particular research topic, discipline, design, method, or location. Spencer Foundation's goal for this program is to support rigorous, intellectually ambitious and technically sound research that is relevant to the most pressing questions and compelling opportunities in education.

## **Eligibility Criteria**

- Projects proposed may not be longer than 5 years in duration.
- Applicants can request funding amount- max USD 500,000 and min USD 125,000
- Principal Investigators (PIs) and Co-PIs must have an earned doctorate in an academic discipline or professional field, or appropriate experience in an education research-related profession. While graduate students may be part of the research team, they may not be named the PI or Co-PI on the proposal.
- Projects that are primarily comprised of activities other than education research (e.g., request for funding book writing, curriculum or technology development, technology purchases, philanthropic support for nonprofits or other service providers, program evaluations), or scholarships are not eligible.

# **How to Apply**

Applications begin with a preproposal, which Spencer uses to decide whether to invite a full proposal. Preproposals must be submitted online by the deadline date.

UCT applicants must begin the internal eRA approval process at the same time as they prepare the Spencer preproposal. These processes run in parallel, so please plan your timeline to meet both the internal and external deadlines.

## **Preproposal Submission Steps**

- **Step 1.** Registration
  - Pls must register on the Spencer online portal <a href="https://spencer.smartsimple.us/">https://spencer.smartsimple.us/</a>
    If the Pl is new to the system, they must first create a profile. Existing users can log in and update their profile.
- Step 2. Complete Your Profile
   Complete the My Profile page and upload a current CV (10-page limit).
- **Step 3.** Create the Preproposal From your Workbench, click Apply under "Large Research Grants on Education". Drafts may be saved and edited until the deadline.

## **UCT Internal Requirements and Deadlines**

The internal approval process must run concurrently with the Spencer preproposal preparation. Please start your eRA steps as soon as you begin drafting your application.

Institutional approval via eRA Internal Approvals forms is required before submission to the funder.
