Working with Project managers and Lead investigators with input from the Principal Investigators and Co-Principal Investigators. The Cape Town post is a fulltime position based at the clinical research site in Khayelitsha as well as supporting studies being conducted at other hospitals by CIDRI-Africa investigators. The Gqeberha post is part-time and based at Livingstone Hospital.(25hrs per week, with flexibility)

- Management of pharmacy activities as required by the sponsor with other members of the pharmacy team
- Preparing and maintaining study documentation
- Study administration; management of pharmacy regulatory files
- Training of new staff and training with current staff as required
- Input into clinic diary control
- Equipment management and maintenance of logs for all equipment in the pharmacy area
- Daily quality control of case report forms (CRFs)
- Creating pharmacy Standard Operating Procedures and input into Clinical Quality Management Plans for each protocol
