The UCT Child Development Research Laboratory (CDRL) invites applications from suitably qualified candidates to fill a Research Nurse post on a 1-year full-time contract. The CDRL in the Division of Biomedical Engineering of the Department of Human Biology studies the effects of prenatal exposure to toxins on infant and child development. We are seeking an experienced, dynamic individual to work on a double-blind, randomized controlled trial of a nutritional supplement in pregnant women. Although the contract will initially be for 1 year, there is potential of renewal for a further 2 to 3 years.

Requirements:

- NQF7 (Nursing Degree equivalent) qualification
- 3 years of experience working as a clinical nurse, including
 - At least 1 year working in a setting with obstetric care, with midwife experience, as well as recognizing and addressing obstetric emergencies
 - Experience interpreting maternal case records
- Excellent communication and interpersonal skills
- Strong decision-making skills
- Administrative and data entry experience
- Valid current South African Nursing Council (SANC) Registration
- Fluency in English and Afrikaans
- Driver's license and access to personal car

- Medical record reviews
