Introductory paragraph

The Department of Obstetrics & Gynaecology in the Faculty of Health Sciences at the University of Cape Town is seeking to appoint a suitably qualified candidate for the position of **Programme Manager.** This post is funded by the Bill and Melinda Gates Foundation towards the establishment of the PEARLS Trial (Preventing pre-eclampsia: Evaluating AspiRin Low-dose regimens following risk Screening). The PEARLS Study is a multi-country, multi-centre, two-arm, parallel, double-blind, placebo-controlled, randomised trial of low-dose aspirin for women at increased risk of pre-eclampsia in Ghana, Kenya and South Africa, to prevent pre-eclampsia and improve maternal and newborn outcomes. The Programme Manager will be responsible for strategy, planning, oversight, and implementation of project and studies nested within the project.

- At least 2 years' experience working in an academic environment.
