

DSI-NRF Postgraduate Student Funding for the 2026 Academic Year – CALL NOW OPEN

The DSTI and NRF are pleased to announce a call for new applications for **SARAO MASTERS Student Funding for the academic year 2026**. All continuing students who are eligible for a second or third year of funding must submit a Progress Report and not a new application.

The NRF **minimum academic requirement** for postgraduate funding is **65%** for the previous degree. Successful applicants will be funded either at **Full Cost of Study (FCS)** or **Partial Cost of Study (PCS)**. The FCS funding will be awarded to South African citizens and Permanent Residents only, who are either **financially needy** (i.e., those whose combined household family income is less than or equal to R350 000 per annum), **living with a disability** or **exceptional academic achievers**. However, the PCS funding will be awarded to **5% of international students** including South African citizens and Permanent Residents who could not be funded under FCS but meet other minimum requirements for the NRF scholarship funding criteria. The scholarships are intended to support master's and doctoral candidates to pursue studies in all areas of **Science, Engineering, Technology, Social Sciences, and Humanities**.

ADDITIONAL REQUIREMENTS

- SARAO will consider applications from South African citizens and permanent residents, as well as from citizens of Botswana, Ghana, Kenya, Madagascar, Mauritius, Mozambique, Namibia and Zambia.
- Applicants intending to register for a professional or coursework only degrees are ineligible
- Applicants intending to register for a master's degree with a research weighting of LESS THAN 50% are not considered and would be deemed ineligible
- Applicants intending to register for part-time study are ineligible
- Applicants who intend to register for any other degree other than master's are ineligible

PROJECTS FOR MASTER'S RESEARCH FOR THE 2026 ACADEMIC YEAR

Applicants are advised that SARAO will **ONLY** consider applications from students who have selected a research project that has been approved by SARAO for **Master's** research in 2026, and who upload a signed letter from the relevant supervisor stating that he/she will supervise the student.

HOW TO APPLY?

- Application forms must be completed on the NRF Connect System at <https://nrfconnect.nrf.ac.za>
- Login or register for ORCID iD
- Complete/Update your personal profile and CV information and upload relevant documents if so applicable
- Select the “SARAO Master’s” option
- Students may only submit ONE application
- Students MUST upload all five required documents
 1. SA and Perm SA citizens - a copy of your **South African ID**. For non-SA a copy of your **passport**
 2. ONE **single PDF of all university academic results** from start of your degree until now
 3. An up-to-date **CV**
 4. **Supervisor-agreement letter**
 5. **Letter of Motivation**. **IF ANY OF THESE FIVE DOCUMENTS ARE NOT ATTACHED TO YOUR APPLICATION, SARAO WILL NOT CONSIDER YOUR APPLICATION.**
- **TWO Letters of Reference** must be emailed directly to study.research@sarao.ac.za **before 15 July 2025 and should include the below information**
 - The capacity in which the referee knows the applicant, and for how long they have known the applicant.
 - The applicant’s academic performance, and attitude to their studies.
 - The applicant’s research capabilities in terms of attitude, initiative, understanding of the subject, progress against deliverables, publications etc.
 - The applicant’s written and verbal communications skills.
 - Any other relevant comments regarding applicant. **IF YOUR APPLICATION IS NOT SUPPORTED BY TWO LETTERS OF REFERENCE SARAO WILL NOT CONSIDER YOUR APPLICATION**

WHAT TO EXPECT AFTER YOUR APPLICATION IS SUBMITTED?

- Once you submit your application, it will automatically be routed to UCT
- For your application to be considered for 2026 funding, you must submit your application and all supporting documentation on or before UCT’s CLOSING DATE
- After DA screening, eligible applications will be submitted to NRF for their further consideration
- Ineligible applications will be rejected. Your application status can be monitored via your NRF Connect Profile

- The NRF will inform all applicants of the outcome of their application

INCOMPLETE APPLICATIONS

Please be advised that no incomplete applications will be submitted to NRF. It is the applicant's responsibility to familiarise themselves with all eligibility criteria and requirements. During DA screening, if your application is incomplete, the office will contact you via email requesting information. Such requests must be responded to within 24 hours. Failure to do so will result in your application being disqualified and as a result, will not be considered.
