Anozie, Ijeoma Francesca
 Thesis Title: *The Responsibility to Protect: Is the government of Nigeria meeting its responsibility to protect the reproductive, maternal health, and child health rights of women and children in internally displaced persons settlements?*

Ijeoma Anozie obtained her LLB and LLM degrees from the University of Nigeria in 2004 and 2018 respectively. This was after she had obtained an earlier degree in English Language from the University of

Jos and followed from her passion for the law profession. She began full-time study towards her doctoral degree in 2019.

Ijeoma Anozie's thesis interrogates the adequacy of the Nigerian legal and institutional framework in protecting the health rights of internally displaced women and children in Internally Displaced Persons' settlements in Nigeria. Her investigation exposed different degrees of flaws with the extant laws, thereby making their implementation difficult. Her findings reveal that the current laws are inadequate to protect the health rights of internally displaced women and children. These findings will help the Nigerian government and other African governments to make laws that will easily be implementable to adequately protect internally displaced women and children.

Thesis Title: A critical analysis of the remedy of reinstatement of mortgage loan agreements in South Africa

Berna Buyis holds a BA LLB from the University of Stellenbosch, an LLM from the University of South Africa and a BA(Hons) in Translation from the University of the Witwatersrand. She began PhD studies in 2022 and currently works in the banking sector.

Berna Buyis' thesis considers the remedy of reinstatement in sections 129(3) and 129(4) of the National Credit Act 34 of 2005 and investigates whether the section is fit for purpose given South Africa's historical and constitutional background. She concludes that the Constitutional Court's consideration of the remedy of reinstatement in the judgment of *Nkata v FirstRand Bank Limited* and Others, as well as the subsequent amendment of the National Credit Act, have not gone far enough in addressing some of the concerns about sections 129(3) and 129(4). After comparing the law of Canada and Scotland, Berna Buyis concludes that, to address these concerns, sections 129(1), 129(3) and 129(4) of the National Credit

Act need to be amended to provide for more practical and coherent provisions. Further subsections also need to be added to section 129 and, in doing so, the section requires some minor consequential amendments.

Thesis Title: Domestication of the protocol to the African Charter on the rights of women in Africa: the Nigerian religio-cultural perspective

Esther Gambe holds an LLB from the University of Lagos, Nigeria, and an LLM from UCT.

Esther Gambe's thesis focuses on religious and cultural challenges to the realisation of women's rights in Nigeria. She analyses various gaps in the Nigerian legal systems on the rights of women, gaps that exist despite Nigeria's ratification of several international and regional laws on the rights of women. She concludes that while the Protocol to the African Charter on the Rights of Women in Africa successfully addresses the religious and cultural discriminations that women continue to endure in Nigeria, it remains undomesticated in that country and, due to the prevalent patriarchal systems there, has no force of law. Her analysis of responses about these challenges that she received from practitioners of Islam, Christianity, and traditional religions within the three main tribes in Nigeria (Hausa/Fulani, Yoruba, and Igbo) leads her to propose an indigenization model that focuses on an intra cultural discourse that would in turn guarantee both the fundamental rights of women and enable the domestication of the Protocol in Nigeria.

Thesis Title: Compliance with regional courts judgments in SADC in the context of regional integration in Africa

Sithembele Madala completed his LLB degree at the Nelson Mandela School of Law, University of Fort Hare in 2014 and LLM degree at UCT in 2018. He registered for his PhD in 2018 and, while completing his studies, also enrolled as a Candidate Attorney in a leading law firm.

Sithembele Madala's thesis investigates the benefits and legal value of the Southern African Development Community (SADC) Tribunal for the rule of law, human rights law, and international access to justice. His thesis focuses on the importance of the SADC Tribunal in a broader context and outside state compliance analysis. His research identifies existing gaps in the study of the SADC Tribunal and demonstrates that, despite the lack of effective enforcement and judgments compliance measures, the SADC Tribunal is a competent judicial institution. Sithembele Madala's study utilised goal-based and institutional design approaches to show that the SADC Tribunal has achieved its primary role of hearing and deciding cases brought before it, thus contributing to the development of SADC jurisprudence and human rights law on the continent.

Moyo, Grace Vongai Zvidozvashe

Thesis Title: From re-traumatisation to rightful recourse: designing just and victim-supportive policies for disciplining campus sexual misconduct

Grace Moyo holds an LLB from Rhodes University, and an LLM in Dispute Resolution from UCT.

Grace Moyo's thesis engages with the problem of sexual misconduct in South African universities concentrating specifically on the effectiveness of institutional mechanisms for resolving complaints. Focused on the disciplinary process, she analyses sexual misconduct policies and procedures in South African

public universities. She identifies a lack of clear procedural rules for disciplinary tribunals and for comprehensive victim support and contends that these shortcomings present an inherent barrier to achieving just outcomes. Grace Moyo argues for a hybrid model of adjudication, grounded in Natural Justice and procedural fairness, and integrating robust victim-supportive measures to alleviate secondary trauma for victims navigating the disciplinary process. Grace Moyo's thesis underscores the imperative for universities to rectify policy deficiencies and to recognise the pivotal role of fair and victim-supportive processes in resolving sexual misconduct complaints.

Thesis Title: Participation in decision-making within prison settings as a tool for enhancing the enjoyment of the right to health: The case of women inmates in Zambia

Chipo Nkhata obtained her LLB from the University of Zambia in 2006, LLM from the University of Cape Town in 2010, and began her PhD studies at UCT in 2017. She worked in the Human Rights Commission of Zambia and teaches Human Rights Law at the University of Zambia.

Chipo Nkhata's thesis examines how women inmates' participation in decision making within prison settings in Zambia can enhance their right to health. Her thesis draws upon data from interviews with women inmates and personnel from governmental and non-governmental institutions on the feasibility of women inmates participating in health governance in Zambia. She finds that women inmates' participation in health decisions and programmes enables them to present their health concerns and share their experiences with duty bearers, thereby putting their issues on the national agenda. She also finds that women inmates' participation in health decisions and programmes improves their social standing as citizens and enhances prison health governance.

On this premise, Chipo Nkhata has formulated a woman-centred model for citizenship participation in health for women inmates in Zambia.

Nyehita, Suzanne Ghati

Thesis Title: Regulating for the equitable remuneration of music artists in Kenya

Suzanne Nyehita is an advocate of the High Court of Kenya. She holds an LLB from Kenyatta University and an LLM from UCT. She commenced her PhD studies in 2018.

Suzanne Nyehita's thesis probes the role of copyright as a remuneration mechanism for music artists and intermediaries involved in the commercialisation of music and distribution of revenue in Kenya. In it she explores how Kenya can achieve a more equitable distribution than presently of music revenue between music artists and intermediaries under copyright law, taking into account how music is commercialised, existing legal structures, and incorporating principles from the Rawlsian theory of justice and the theory of paternalism. She proposes an approach that ensures equity across the different phases of music commercialisation and revenue distribution, including the acquisition of rights, transitional periods during reform implementation, and reparations for violations of safeguards of music artists' rights. Ultimately, Suzanne Nyehita suggests reforms to Kenya's copyright system based on examples from Germany, the European Union and South Africa.

Thesis Title: Constitutional limits on the application of the political question doctrine: a study of Kenya, South Africa and Ghana

Ronald Ong'udi holds a Bachelor of Laws from Moi University, Kenya, a Postgraduate Diploma in Law from the Kenya School of Law, and a Master of Laws from Deakin University, Australia. Ronald is a practising advocate of the High Court in Kenya.

Ronald Ong'udi's thesis explores the constitutional limits constraining judges when they review political questions. He argues that, within their review jurisdiction, judges either permissibly or impermissibly intrude into terrain reserved for a state's political branches. He explains that the difference between the two lies in how judges interpret the text of a country's constitution. Through considering examples from jurisdictions of Kenya, Ghana and South Africa, Ronald Ong'udi makes a case for an approach to interpretation that respects the plain meaning of constitutional text and acknowledges the institutional limits of the judiciary in the face of political questions. He regards a constitutionally permissible intrusion as one where judges maintain fidelity to text in their interpretation of the constitution whilst acknowledging the institutional limits of their authority, whereas he sees a constitutionally impermissible intrusion as one when judges depart from the plain meaning of constitutional text and fail to acknowledge the institutional limits of their authority.

Smith, Samantha

Thesis Title: *Sanctioned suffering: How South Africa's animal law framework facilitates the exploitation of farmed animals*

Samantha Smith holds BSocSc, LLB, and LLM (with distinction) degrees from UCT. Having previously worked in legal research, she is now a large law firm's chief legal editor and content writer, and is awaiting admission as an Attorney, Notary Public, and Conveyancer of the High Court of South Africa.

Samantha Smith's thesis provides a detailed exposition of South African law's role in enabling the institutional exploitation of animals in agricultural settings. Against a dearth of local scholarship, she illuminates and critiques the unquestioned legal mechanisms that reduce sentient beings to 'livestock' for human use. Commencing with an analysis of Roman-Dutch law, she explores the enduring person/thing distinction which gives legal expression to a human-nonhuman animal binary. Examining the codification of animals' legal thinghood, she demonstrates how agricultural statutes legitimise the reproductive manipulation, bodily mutilation, and slaughter of farmed animals, with little concern for their material interests. In a critical analysis of the animal protection framework, she explores how 'cruelty' is narrowly defined to exempt intensive confinement systems and painful management practices from the scope of criminal liability. Beyond statutory law, she reveals how industry-sanctioned Codes and Standards are designed to advance agribusiness's pecuniary interests under the guise of animal welfare.

The Chancellor wears a gown made from dark blue silk. The front of the gown has facings down each side made of dark blue velvet embroidered with a gold floral design. The gown and sleeves are lined with pale blue silk and the sleeves are looped up in front with a gold cord and button. The yoke of the gown is edged with gold cord. The gown is worn with a square blue velvet hat with a soft crown and gold tassel.

VICE-CHANCELLOR

The Vice-Chancellor wears a gown made from bright blue silk. The front of the gown has facings down each side and sleeve-linings of pale blue silk. The sleeves are looped up in front with a gold cord and button and the yoke of the gown is edged with gold cord. The gown is worn with a black velvet bonnet with a silver cord.

DEPUTY VICE-CHANCELLOR

A Deputy Vice-Chancellor wears a gown made from dark blue silk. The gown has closed sleeves with an inverted T-shaped opening at the level of the elbow to free the arms. The front of the gown has facings of light blue down each side. The sleeves are lined with light blue and the yoke of the gown is edged with silver cord. The gown is worn with a black velvet bonnet with a silver cord.

CHAIR OF COUNCIL

The Chair of Council wears a gown, of the same pattern as that worn by the Vice-Chancellor, made from light blue silk. The front of the gown has facings down each side and a yoke of dark blue. The sleeves are lined with dark blue and the facings and yoke are trimmed with gold cord. The sleeves are looped up in front with a gold cord and button. The gown is worn with a black velvet bonnet with a gold tassel.

MEMBERS OF COUNCIL

Members of Council wear graduate-pattern gowns made from black silk. The front of the gown has 10cm wide, light blue facings down each side trimmed with dark blue cord. The gown is worn with a black velvet bonnet with a blue cord.

REGISTRAR

The Registrar wears a gown made from black silk. The front of the gown has 10cm wide facings of blue silk down each side. The gown is worn with a black velvet bonnet with a white cord.

PRESIDENT OF CONVOCATION

The President of Convocation wears a gown made from black silk and has long closed sleeves with an inverted T-shaped opening at the level of the elbow to free the arms. The front of the gown has facings down each side and sleeves of blue silk. The gown is worn with a black velvet bonnet with a blue tassel.

UNIVERSITY ORATOR

The University Orator wears a gown of gold silk with bright blue silk facings and a yoke edged with gold cord. A black mortar board with a gold tassel is worn with the gown.

ACADEMIC DRESS (continued)

GOWNS

A plain black gown styled after the pattern of the Oxford scholar's gown is worn by diplomats, and Bachelor's, Honours and Master's graduands. Senior doctoral graduands wear a scarlet gown, with facings the colour distinctive of the faculty in which the degree is awarded. PhD graduands wear a scarlet gown without facings.

HOODS

The hood is particular to the qualification and the faculty. Diplomates and Bachelor's graduands wear a black hood lined with white and edged with the colour distinctive of the faculty. Master's graduands wear a black hood lined with the colour distinctive of the faculty and edged with white, except in the case of the hood for the MMed degree, which is edged with red.
