About the Funding Opportunity

The British Academy invites proposals for its next round of <u>Knowledge Frontiers: International Interdisciplinary Research Projects.</u> The programme supports pioneering international collaborations led by UK-based researchers in the humanities and social sciences, working with international partners and engaging across disciplines (including STEM and SHAPE) to address urgent **Transnational and Planetary Challenges**.

Programme Aims: Projects must be grounded in the humanities and/or social sciences and:

- Address at least one of the following four transnational and planetary domains:
 - Earth system governance (e.g., climate change, biodiversity loss, oceanic degradation)
 - o **Digital & transformative technologies** (e.g., AI, cyber, nanotech, synthetic biology)
 - o **Global health** (e.g., pandemics, "One Health" approaches)
 - Outer space governance (e.g., orbital debris, arms racing in space)
- Be genuinely interdisciplinary, involving cross-disciplinary collaboration among SHAPE and STEM researchers
- Contribute to deeper, more historically aware thinking
- Support international knowledge exchange and policy development
- Enable effective international, cross-disciplinary, and multilingual collaboration

Eligibility Criteria

- **Principal Investigator (PI):** Must be a humanities or social sciences researcher, based at a UK university/research institute, postdoctoral or above, with a contract extending for the full project period. PIs must dedicate a minimum of 20% FTE to the project.
- **Co-Applicants:** Must include at least one Co-Applicant based overseas. Teams must demonstrate genuine interdisciplinarity across SHAPE and STEM disciplines.
- Researchers based at UCT or other eligible institutions in the Global South may participate as CoApplicants, provided they collaborate with a UK-based Principal Investigator from the humanities
 or social sciences. This is a collaborative submission led by the UK PI, who will submit the application
 via the funder portal. Interested UCT researchers are encouraged to identify and engage with eligible
 UK-based collaborators early to jointly develop proposals aligned with the programme's
 interdisciplinary and transnational research objectives.
